#### **GENERAL**

- RICCO FS is mainly used for upper and bag leathers where it gives a pleasant handle.
- Leathers retanned with **RICCO FS** have a very fine and flat grain.
- RICCO FS's light fastness is very high.
- RICCO FS eliminates the shrinkage and cracks on the grain, when used with vegetable tannins. RICCO FS disperses vegetable tanning agents and improves their uptake and distribution in the leather.
- RICCO FS is used as a retanning agent for upper leathers where 3-6% is applied during retanning. Glazed leathers are retanned with 3-5% RICCO FS . Polished leathers benefit from a retannage with RICCO FS . Adding 2-3% RICCO FS before the retannage improves the flatness of the neck part in waterproof leathers.
